

## **Greener Footprints week poster competition Terms and Conditions**

**By entering into the Greener Footprints Week Poster competition you are agreeing to fully adhere to the following terms and conditions.**

**1: Eligibility:** The competition is only open to Primary Schools in the county of Herefordshire. All entries must come through a school registered email address. Employees of Herefordshire Council Sustainability and Climate Change team, members of their family or other associated persons working professionally on the Greener Footprints campaign are not eligible to win a prize.

**2: Promotion requirement:** The draw is free to enter and no purchase is necessary. Internet access/an email registration is required to enter these promotions

**3: How can I enter the promotion?** To enter the Greener Footprints Week poster competition, submissions are to be sent to [info@greenerfootprints.co.uk](mailto:info@greenerfootprints.co.uk), and include details of student's age(s), school name and materials used in the creation of the poster. Designs must be in a footprint shape, using or mimicking the template provided.

**4: How many times can I enter?** Participating schools can enter up to 6 submissions. If more than 6 submissions are received from the same school, only the first 6 will be entered into the competition. No responsibility will be accepted for entries lost, damaged or delayed or for technical, telecommunication or website error. The Promoters reserve the right to disqualify incomplete, altered or illegible entries. Proof of entry is not proof of receipt.

**5: Winner selection process:** A shortlist of entries will be selected by the staff on the Sustainability and Climate Change Team of Herefordshire Council. From the shortlist, a panel of judges from the Herefordshire Climate and Nature Partnership Board will select one winner in each category. Winners will be notified within 3 weeks of competition close via the email used for submission. If the winner cannot be contacted or does not acknowledge the win within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner. •Entrant's age and school name will be announced on social media and on our website. If you do not wish for this data to be shared you should make this explicit on the email entry. Further details may be shared with explicit permissions.

**6: The prize:** The school from which the winning entry is received in each age category will receive £250. Prize vouchers will be awarded in voucher form and must be utilized toward environmental education materials, such as school garden projects, forest school

supplies, or eco-group projects. Schools will be required to outline intended use of funds before receiving prize money.

**7: Data Protection:** Your personal details will be kept confidential at all times in accordance with the Data Protection Act and our [Privacy Notice](#). Data will be used solely for the purposes of this promotion and will not be disclosed to a third party without the individual's prior consent. By entering this promotion you consent to the use of your personal data by the Promoter for the purposes of administration of the promotion. The Promoter will only use this data for marketing purposes where you have given clear consent.
