- Farming & Land Use Project Whole farm/field scale Phosphate Measurement Tool to replace Farmscoper (SK)
- SK proposed a bespoke phosphate tool for the county to the board, it needs to be
 Herefordshire specific as a national tool would not accurately reflect local conditions (extreme
 variations in soils).
- Current software is outdated (5/10 years without update)
- Emma has bid for funding to add Phosphate balancing into calculator (Farm Carbon Audit)
- Board cannot yet agree on supporting the tool, action subgroup need to work up a proposal to bring back to the board
- Action have all projects on web and have board members accountable to board for delivery with SCC support.
